

Inventory existing and proposed multi-use trails in the Commonwealth


Identify key gaps in Virginia's network of multi-use trails


Statewide Trails Plan – Phase 2



Identify physical barriers to trails



Analyze connections to multimodal networks



Aggregate local, state, and federal funding resources



Develop standards and guidance for context sensitive trail design



Resource Hub

- A resource site for all types of trails in Virginia
- Map existing trail facilities
 - Shared-use paths
 - Rail-to-Trail/Rail-with-Trail
 - Single track
 - State Park trail
 - Publicly and privately owned-publicly accessible trails
- Collaborate with stakeholders to refine content that best meets the needs of end users.
- Standardize trail input attributes
- Spatialize trails data and develop an interactive mapping interface



Resource Hub – Initial Steps

- ➤ 1500 miles of existing multiuse trails
- 2900 miles of planned multiuse trails
- Attributes:
 - > Trail Name
 - Trail Surface Type
 - > Trail Use
 - Width in Feet
 - Segment Length
 - Trail Open Date
 - Locality Name
 - Ownership and Maintenance Structure



Trails Data Inventory (January 2024)

Trail Design and Cost Guidelines

- Context sensitive design guidelines
- List the different trail contexts in Virginia
 - Coastal
 - Mountain
 - Environmentally sensitive areas
 - Urban, Suburban, Rural
- Identify trail criteria and attributes that impact cost
 - Surface material
 - Width
 - Structures
- Decision matrix for trail development based on location, design, and federal/state funding eligibility criteria







STAC Recommended Priorities for 2024/25 Reporting Year

Each table should:

- Review recommendations identified in § 10.1-204.1.B
- Identify #1 priority from these recommendations and how many to focus on in the coming year
- Facilitator to report out to group



The Advisory Committee shall examine and provide recommendations regarding:

- (i) options to close the gaps in a statewide system of trails as described in § 10.1-2047 ;
- (ii) creative public and private funding strategies and partnerships to leverage resources to fund the development of trails;
- (iii) integrated approaches to promote and market trail values and benefits;
- (iv) the development of specialty trails, including concepts related to old-growth forest trails across the Commonwealth;
- (v) strategies to encourage and create linkages between communities and open space;
- (vi) strategies to foster communication and networking among trail stakeholders;
- (vii) strategies to increase tourism and commercial activities associated with a statewide trail system;
- (viii) strategies to enhance the involvement of organizations that promote outdoor youth activities, including the Boy Scouts of the U.S.A. and Girl Scouts of the U.S.A. and the 4-H program of the Virginia Cooperative Extension; and
- (ix) other practices, standards, statutes, and guidelines that the Director of the Department of Conservation and Recreation determines may enhance the effectiveness of trail planning across the Commonwealth, including methods for receiving input regarding potential trail impacts upon owners of underlying or neighboring properties.
