

# ABOUT US



## Mission:

The mission of the VASWCD is to serve and strengthen all soil and water conservation districts in the stewardship of agricultural and natural resources. The Educational Foundation works to provide and promote leadership in the conservation of natural resources through stewardship, education and awards programs. The VASWCD and its Foundation coordinates conservation efforts statewide to focus effectively on issues identified by local member districts.

## VASWCD

The Virginia Association of Soil and Water Conservation Districts (VASWCD) is a private nonprofit association of 47 soil and water conservation districts in Virginia and is classified accordingly as a 501(c)(5). It is a voluntary, nongovernmental association of Virginia's districts.

The VASWCD's voting members are all elected and appointed directors. SWCDs were established in the 1930s as political subdivisions of the state in response to the pressing need for the conservation of our natural resources in the Commonwealth. Each local SWCD is directed by a board of elected and appointed directors who are elected in general elections and serve four-year terms.

The VASWCD is governed by a 12-member board, all of whom must also be Directors. A President, 1st Vice President, 2nd Vice President, Past President, Secretary/Treasurer, and representative to the National Association of Conservation Districts (NACD) constitute the executive committee and are empowered to act on behalf of the board between meetings. The state of Virginia is divided into six geographic areas. SWCD directors within each area elect two directors to serve as Area Chair and Area Vice Chair. The Area Chair serves on the VASWCD Board and represents his/her respective SWCDs.

## VASWCDEF

The VASWCD Educational Foundation is nonprofit and classified as a 501(c)(3) organization that was established in 1990. The mission of the Virginia Association of Soil and Water Conservation Districts Educational Foundation is to provide and promote leadership in the conservation of natural resources through stewardship, education and awards programs.

Funding for activities such as Envirothon and Youth Conservation Camp are provided through donations made by individuals, corporations, organizations and other foundations as well as fundraising efforts. Contributions to the VASWCD Educational Foundation are used to support educational efforts within the Commonwealth and are tax deductible.

The Association Officers and the Area Chairs shall constitute the full Foundation Board of Directors in addition to a separately elected President, Vice President and Treasurer.

- Serve on a minimum of one VASWCD committee. Assist the Association in other activities and committee member recruitment when appropriate.
- Serve on the DCR Cost Share Technical Advisory Committee. However, in lieu of personal service, the Chair may appoint a representative, from that Area to serve instead.

## VSWCB RESPONSIBILITIES

The Virginia Soil and Water Conservation Board was established by the General Assembly to help guide the delivery of soil and water conservation services to citizens of the commonwealth. The board is supported mainly by DCR staff for programs covering soil and water conservation and dam safety and floodplain management. The board's responsibilities include:

- Oversight and support of Virginia's soil and water conservation districts (SWCDs), including financial support, coordination, information exchange, the formation of districts, adjustments to their boundaries as well as other specified duties.
- Oversight and enforcement of dam safety and floodplain management programs and regulations.
- Approval of loan criteria for loans from the Dam Safety, Flood Prevention and Protection Assistance Fund.


