## **Photography Permit Conditions**

- 1) Park rules and regulations are enforced at all times. Permit does not exempt holder from park rules or provide access to any area closed to the public.
- 2) Photo sessions may not impede other visitors' normal use and enjoyment of park resources, nor interfere or infringe upon park programs, events or other park-permitted functions.
- 3) Permitted photo vendors are encouraged to contact the Park, (804) 462-5030, at least 48 hours in advance of each visit to be informed of any programs, events, or other permitted functions that may preclude desired session location or time.
- 4) Generally, photo sessions may be conducted anywhere throughout the park's beautiful 892 acres with the exception of:
  - a. The Bel Air Area unless the client has the house(s) rented during that session.
  - b. Within or leaning against the red barn.
  - c. Campgrounds, maintenance, or other restricted areas.
  - d. Park residences shall not be photographed or allowed to appear in any photographs. This is a courtesy to the occupants and will be strictly enforced.
  - e. Rented Picnic Shelters unless rented by your client or you.
  - f. Obstruction of trails, roads, parking areas, or other avenues of normal use flow.
  - g. Other unacceptable locations may be determined based on program or other mission-based uses.
- 5) The vendor is required to carry the Belle Isle issued approved permit while conducting photography sessions. This must be shown to any ranger who asks to see it.
- 6) Parking is permitted in designated areas only.
- 7) The vendor is required to provide identification for their vehicle and the vehicles of any clients. This can be easily done by placing a copy of the permit in a readable location of the dashboard of all related vehicles. Unmarked vehicles are subject to fines.
- 8) Park opening and closing times must be observed.
- 9) Permit conditions may be updated by the park at any time. Updates will be sent to the permit holder via email address on record.
- 10) Failure to meet the obligations of permit will result in revocation of the remainder of the permit year without refund.
- 11) The Park reserves the right to refuse any requested session date(s) and location(s) due to conflicts with other Park activities.
- 12) The annual permit fee is \$250 and extends for the calendar year. This fee covers parking fees for the vendor and clients. The annual fee will be prorated based on the month of application. Photographers are responsible for annual renewals.
- 13) The park will keep a list of permitted photographers that will be shared with guests inquiring about these services. There are often requests for weddings and other events that may be looking for these services.
